# Executive Summary

"The Contributing to Modern Partnerships: Assessments of Sino-EU- Serbian Relations project (hereafter referred to as COMPASS) aims to identify, analyse, and provide recommendations regarding the risks associated with Serbia's political, security and economic cooperation with the EU and China. The main objective and outcome of the project is to give recommendations on how to reduce or mitigate these identified risks.

The initial phase of this project, part of Work Package 1, involved conducting a literature review and gathering relevant data about the research topic. The second phase entailed assessing potential risks in multilateral cooperation, followed by the third phase, which included conducting a public opinion survey to gather wider attitudes and stances of the general public on the main directions and aspects of Serbia's foreign policy relations.

The survey was conducted from April 23, 2025 to July 3, 2025. It had 1104 responses.

The survey was conducted online using a structured questionnaire format. The sample was randomly selected, yet the sociodemographic variables demonstrated a significant level of representativeness compared to the general population. The questionnaire was completed by citizens of the Republic of Serbia. It was administered in Serbian and ensured complete anonymity for all respondents. In addition to generally required info regarding respondents' age, level of education, sex, place of living and overall assessment of their knowledge of the topic, the survey consisted of 20 questions, ofwhich several had multiple aspects.

The respondents were informed about the purpose of the research, anonymity, and usage of gathered data.










1. In your opinion, which international partner contributes the most to the protection of the national interests and territorial integrity of the Republic of Serbia?





2. Which country in the region do you see as Serbia's greatest friend?




3. When do you expect Republic of Serbia to join the European Union?

5. Who was the largest investor in Serbia during the period 2013-2023?



6. Who was Serbia's largest foreign trade partner during the period 2013-2023?






7. Do you think Serbia is accumulating too much debt with China for infrastructure projects?





8. Do infrastructure projects financed by China contribute to the economic development of Serbia?








10a. How would you assess the political and economic cooperation of the Republic of Serbia with China in the last 10 years?






10b. How would you assess the political and economic cooperation of the Republic of Serbia with Russia in the last 10 years?





10c. How would you assess the political and economic cooperation of the Republic of Serbia with USA in the last 10 years?









10d. How would you assess the political and economic cooperation of the Republic of Serbia with European Union in the last 10 years?







12. Is EU membership a "strategic foreign policy goal" for Serbia?









An unacceptable economic and political partner, we do not share any common values | 30.6%





17. To what extent do the following questions influence the foreign policy orientation of the Republic of Serbia?



Tariff "wars" (US tariffs and responses from other countries)









# Militarization of the European Union (significant increase in defense spending)









Tensions in the Asia-Pacific (Taiwan, increase in military budgets of China and Japan)











How do you assess the attitude of the following leader towards the Republic of Serbia: Vladimir Putin (Russia)?





How do you assess the attitude of the following leader towards the Republic of Serbia: Xi Jinping (China)?






How do you assess the attitude of the following leader towards the Republic of Serbia: Victor Orban (Hungary)?
